INSTRUCTIONS

- Vendor check-in is from 8am – 9am. Vendors are expected to check in and have all loading vehicles removed from Vendor area by 9am. Vendors should have all merchandise setup completed and be ready for business by 11am.
- Vendor location is determined by the First Flight Cruisers. Any vendor space requests will be considered on a first come first served basis.
- Tents, tables, chairs and power requirements are the responsibility of each vendor. Tents, easy-ups, signs, and merchandise must be properly anchored. Note: some vendor spaces are on asphalt, some are on grass. Please prepare for either or submit preference prior to event.
- All vendors are required to preside over their spaces.
- Vendors must remain in place until 4pm (or as advised by event coordinator).
- Vendors are not permitted to pass out flyers throughout the event crowd.
- Event is rain or shine. An application is a commitment to show and no refund will be made once accepted.
- Decisions of the First Flight Cruisers and the Town of Kill Devil Hills are final.
